## **POSITION SUMMARY**

The Research Officer will work under general to broad supervision in undertaking activities for the Australian Research Council funded Industry Laureate grant 'Breaking the Prison-Reoffending Cycle: A Desistance From Crime Approach' (IL240100059) to help achieve project outcomes. The Research Officer will be responsible for: coordination and preparation of research documentation and ethics applications; liaising with relevant stakeholders (including but not limited to Governors and other senior leaders of NSW correctional centres, senior and other personnel in professional roles across Corrective Services NSW, national and international leaders in correctional theory and practice including members of the Project Advisory Group); assisting with data collection, storage and some limited types of analysis; undertaking literature reviews; assisting with collation of data for report writing and publications; and organising project team travel itineraries.

The Research Officer will be responsible for:

- Working with the Project Leads (the Chief Investigator, Post Doctoral and PhD candidates) to support and enhance their research and research-related activities.
- Preparation and monitoring of ethics applications (University and Industry-based submissions).
- Sourcing and reviewing/summarising relevant literature and other information.
- Maintenance of data collection tools and systems as well as some data analysis.
- Organising, attending and summarising actions of meetings as well as organising other key events/conferences.
- Assisting to prepare and revise publications and presentations.
- Design and maintenance of a whole of project website including disseminating and updating project findings through the website and other avenues.
- Coordinating, planning and executing tasks required to collaborate with industry partners.
- Contributing to establishing and maintaining collaborations within the University, and at State, national and international levels in order to improve research outputs and publications.
- Any other responsibilities in line with the level of the position as assigned by the Supervisor and/or the University.
- Some out of hours work (including weekends) as well as rural SA, interstate and overseas travel, may be required.
