## **POSITION SUMMARY**

Under broad direction, the role is responsible for leading, managing and successfully delivering the Cyber Security Roadmap - Technology Consolidation & Cyber Security Roadmap - Threat to Assurance Project using fit for purpose approaches and methodologies (e.g. waterfall, agile or hybrid) that deliver business value and outcomes in an effective and sustainable manner.

The role is responsible for motivating associated project teams and working collaboratively with key stakeholders to achieve the desired business outcomes.

The role provides senior level leadership and coaching to the associated project teams and other project managers to ensure information technology solutions are delivered and implemented in an effective and sustainable manner.

### **UNIVERSITY EXPECTATIONS AND VALUES**

#### **Core Project Responsibilities**

- 1. Leading on the planning, executing and reporting on the project and delivering complex information technology solutions with enterprise-wide impacts.
- 2. Defining, delivering and meeting project objectives, in terms of approved costs, benefits, schedule, scope, quality and risks.
- 3. Leading and managing associated project teams of varying size, comprising IDS staff, business representatives and staff from third party suppliers.

## **Project Planning, Analysis & Performance**

- 4. Planning, forecasting, managing and reporting project costs, benefits, schedule, scope, quality and risks to the expectation of project stakeholders and customers.
- 5. Defining roles and activities and evaluating performance for input into annual performance reviews, for project team members.

# **Project Collaboration & Stakeholder Management**

- 6. Collaborating with multiple and varied stakeholders across all levels of the University to deliver projects and desired business outcomes in a transparent, effective and measurable way.
- 7. Negotiating with internal stakeholders and external service providers for provision of services from specialist resources, including integration, testing and other specialists to support the delivery of projects.

# Risk, Governance & Ways of Working

- 8. Managing day-to-day vendor interactions and relationships using sound commercial judgement in accordance with University procurement policies.
- 9. Establishing and maintaining agile based ways of working (where appropriate) to manage, refine and prioritise the activity backlog based on relevant customer and IDS priorities.
- 10. Ensuring efficient and effective governance of project decisions, risks and issues in line with IDS frameworks and methodologies.
- 11. Identifying, managing and mitigating risks related to the activities being undertaken by the role in line with IDS and Flinders University policies and procedures.
- 12. Ensuring compliance with all relevant IDS and Flinders University policies and procedures.

- Appropriate tertiary qualification in Information Technology or relevant technical area, and / or equivalent relevant experience in an IT environment.
- Advanced strategic thinking, planning and analytical skills and actively contributes to achieve outcomes and meet the University's strategic goals.
- High-level skills in leading a team to its full potential, including advanced interpersonal and relationship management skills and the ability to manage staff performance, including unsatisfactory performance.
- Extensive experience in building and managing customer relationships in a strategic and long-term context.
- Extensive experience in agile ways of working including exposure to scaled agile methodologies and/or collaborating and delivering through a matrix structure.
- High-level self-improvement and growth mindset/approach to the role and fosters it amongst the wider team.
- Advanced interpersonal influence and demonstrated ability to negotiate and communicate effectively with staff and customers across a diverse organisation particularly during the design, management and implementation of customer solutions.
- Advanced, relevant and current industry training and certifications in project management and enterprise agile methodologies.
- Extensive experience in agile project management for the delivery of large, complex, enterprise-level
  projects comprising multiple agile teams and/or requiring integration with other activities outside the
  scope of the agile teams.
- Extensive experience in establishing and applying project processes and procedures that support the system development life cycle including adaptation of processes and procedures to suit specific circumstances.
- Higher education experience advantageous.
