

## **Master of Business Administration tuition fee discount for Domestic Alumni and Flinders Staff**

A discount is available for eligible Alumni and Staff applying for 2025 entry into one of the following Flinders MBA courses:

- MBA Future Business
- MBA Industry Focused
- MBA (Marketing)
- MBA (International Business)
- MBA (Business Analytics)
- MBA (Healthcare Management)
- MBA (Human Resource Management)
- MBA (Finance)
- MBA (Social Impact)
- PhD-MBA (for the MBA component of the course)
- Graduate Certificate in Business Administration
- Graduate Diploma in Business Administration

### **Value**

#### Flinders Alumni

- A 20% discount in tuition fees is available.

#### Current Flinders staff

- A 30% discount in tuition fees is available.
- Flinders staff can also access the staff professional development fund of up to \$3,500 in conjunction with the discount (subject to meeting eligibility criteria).

### **Eligibility**

Applicants must:

- Meet the minimum course entry requirements; and
- Be graduates of a Flinders undergraduate or postgraduate course to be eligible for the Alumni discount; or
- Be current staff, regardless of mode of employment, to be eligible for the staff discount; and
- Must be an Australian or New Zealand citizen or an Australian permanent resident or permanent humanitarian visa holder at the time of application.

## Terms & Conditions

- The discount cannot be retrospectively applied to admitted students who have commenced the course in previous years.
- Applicants who are not eligible for entry into the one of the MBA courses but are assessed as eligible for an alternate offer into either the Graduate Certificate in Business Administration or the Graduate Diploma in Business Administration will have the discount applied for the alternate course.
- Should an applicant be eligible for both the Alumni and Staff discount, the Staff discount (30%) will be applied if successful in their application for entry.
- The discount will be applied to the student's tuition fee account, including applicants with credit transfer from Flinders study or from another institution.
- The discount will also be applied to students transferring from one specialisation to another i.e. MBA to MBA (Health).
- Recipients can defer their discounted tuition fee repayments through FEE-HELP (if eligible).
- Applicants eligible for the Staff discount should note they may be subject to Fringe Benefit Tax if there is not sufficient connection between the employee's current role and their course.
- There is no financial payout of any unexpended portion of this discount, nor is it refundable if a recipient withdraws from the course or is withdrawn due to unsatisfactory academic progress.
- The discount is not transferrable to a third party.
- The discount will not be extended beyond any advertised duration or amount unless otherwise advised by Flinders University.
- The discount will be revoked if any information submitted with the application is found to be false or misleading.
- The discount may not be available again to recipients who withdraw from the course after commencement and then reapply for readmission in a later year(s).
