A statutory declaration under the *Statutory Declarations Act 1959* may be made before –

A person who is currently licensed or registered under a law to practise in one of the following occupations:

A person who is enrolled on the roll of the Supreme Court of a State or Territory, or the High Court of Australia, as a legal practitioner (however described); or

 - i. Chartered Accountants Australia and New Zealand;
 - ii. the Association of Taxation and Management Accountants;
 - iii. CPA Australia;

Agent of the Australian Postal Corporation who is in charge of an office supplying postal services to the public

APS employee engaged on an ongoing basis with 5 or more years of continuous service who is not specified in another item in this list

Bank officer with 5 or more continuous years of service

Building society officer with 5 or more years of continuous service

Credit union officer with 5 or more years of continuous service

Employee of a Commonwealth authority engaged on a permanent basis with 5 or more years of continuous service who is not specified in another item in this list

Employee of the Australian Trade Commission who is:

- in a country or place outside Australia; and
- authorised under paragraph 3 (d) of the *Consular Fees Act 1955*;
- and exercising his or her function in that place

Employee of the Commonwealth who is:

- in a country or place outside Australia; and
- authorised under paragraph 3 (c) of the *Consular Fees Act 1955*; and
- exercising his or her function in that place

Engineer who is:

- a member of Engineers Australia, other than at the grade of student; or
- a Registered Professional Engineer of Professionals Australia; or
- registered as an engineer under a law of the Commonwealth, a State or Territory; or
- registered on the National Engineering Register by Engineers Australia

Finance company officer with 5 or more years of continuous service

Holder of a statutory office not specified in another item in this list

Justice of the Peace

Magistrate

Marriage celebrant registered under Subdivision C of Division 1 of Part IV of the *Marriage Act 1961*

Master of a court

Member of the Australian Defence Force who is:

- an officer; or
- non-commissioned officer within the meaning of the Defence Force Discipline Act 1982 with 5 or more years of continuous service; or
- a warrant officer within the meaning of that Act

Member of the Australasian Institute of Mining and Metallurgy

Member of the Governance Institute of Australia Ltd

Member of:

- the Parliament of the Commonwealth; or
- the Parliament of a State; or
- a Territory legislature; or
- a local government authority

Minister of religion registered under Subdivision A of Division 1 of Part IV of the *Marriage Act 1961*

Notary public including a notary public (however described) exercising functions at a place outside

- the Commonwealth
- the external Territories of the Commonwealth

Permanent employee of the Australian Postal Corporation with 5 or more years of continuous service who is employed in an office supplying postal services to the public.

Permanent employee of:

- a State or Territory or a State or Territory authority
 - a local government authority
- with 5 or more years of continuous service other than such an employee who is specified in another item of this list

Person before whom a statutory declaration may be made under the law of the State or Territory in which the declaration is made

- Police officer
- Registrar, or Deputy Registrar, of a court
- Senior Executive Service employee of a Commonwealth authority
- Senior executive employee of a State or Territory
