Terms and Conditions

Scholarship Spirit

The Flinders University Academy (FUA) recognise the efforts and academic excellence achieved by international students who have successfully completed their Year 12 studies in Australia. To support them with smoothly transitioning into the new environment, Flinders University Academy launches the 2023 Round School Leaver Study Bursary to showcase our firm commitment to support our international students.

Value

A one-off \$1,500 reduction in full course tuition fees.

Eligibility, application and selection

- Available to new students only who successfully complete an Australian high school curriculum either onshore or offshore, enrolling in intakes commencing in a FUA Diploma or Foundation Studies course in Trimester One, 2024. Acceptances deferred to a later intake will not be eligible for the Bursary.
- Available to new applicant who accept their offer and pay the required acceptance fee by 10th January 2024.
- Available only to full fee-paying international students of any nationality (citizens of Australia and New Zealand and Australian Permanent Residents or other permanent visa holders are ineligible to apply).
- Applicants must hold a valid Flinders Academy packaged offer. Their packaged Flinders Academy course needs to be one of the Foundation Studies or Diploma courses.
- Applicants may hold Flinders University Academy 2023 Round School Leaver Study Bursary and other Flinders Academy scholarships concurrently.
- There is no separate scholarship application process for the Flinders University Academy International Travel Bursary. Applications for Flinders University Academy 2023 Round School Leaver Study Bursary will automatically be assessed for eligibility and eligible applicants will be notified with their Letter of Offer to the course. Eligible applicants simply need to return the course Acceptance Form for the Bursary to be awarded.

Exclusions

- The Bursary is not available to students transferring to Flinders University Academy with credit from studies completed at another institution.
- The Bursary is not applicable to sponsored international students.

Continuing eligibility conditions

Recipients of the Flinders University Academy 2023 Round School Leaver Study Bursary are required to:

- actively support Flinders University in promoting the University and Flinders University Academy globally, including, as required, participating in marketing or promotional activities including but not limited to photo shoots, testimonials and other designated activities
- maintain full time enrolment (unless an underload has been authorised by Flinders University Academy). If a Bursary recipient enrolls in less than a full-time load in any semester covered by the Bursary without authorisation from Flinders University Academy, that semester's portion of the Bursary is forfeited. The Bursary may be reactivated once the student enrolls in a full-time load in the next semester however, the full value of the Bursary will not be disbursed
- maintain continuous enrolment without deferrals or suspensions (unless a temporary suspension has been authorised by Flinders University Academy)
- maintain international student status for the duration of enrolment
- Meet payment deadlines for the remaining portion of tuition fees for each study period. The Bursary will be revoked unless all remaining fees are paid by the advertised payment date. In exceptional circumstances Student Financial Services may approve a payment extension or instalment plan, in which case the Bursary can be maintained.

The Bursary will be revoked if:

- any information submitted with the application is found to be false or misleading.
- the recipient is awarded another scholarship (to be determined by Flinders University Academy).
- the recipient fails to adhere to the terms and conditions of the Bursary.

Delivery of scholarship

- The Bursary is awarded as a tuition fee reduction and will be paid directly into the student's tuition fee account.
- The Bursary is applied as a reduction to tuition fees applicable for the second study period.
- The Bursary provide a tuition fee waiver and do not cover the costs of any non-tuition fees, visas, overseas health cover, living expenses or any other costs associated with living in Adelaide or studying at Flinders University Academy.
- There is no financial payout of any unexpended portion of this Bursary, nor is it refundable.
- The Bursary is not transferrable to a third party.
- The Bursary will not be extended beyond the advertised duration or amount unless otherwise advised by Flinders University Academy.
- If a recipient voluntarily withdraws from Flinders University Academy without completing 50% of the units required for the course, the recipient will be liable to repay the value of the Bursary disbursed from the date of admission to the date of withdrawal.

These terms and conditions may be updated during the period of the Bursary. Recipients will be notified via Flinders email account of any changes.
